By using this site, you agree to these terms of use. If you do not agree to these terms, you may not use this site. Delaware Valley Pagan Network, Inc. (DVPN), sponsor of the Pagan Arts Initiative (PAI), reserves the right, at any time to modify, alter, or update these Terms of Use, and you agree to be bound by such modifications, alterations and updates.
